# VILLAGE OF MILLERTON Board of Trustees Special Meeting April 1, 2024 6:00 PM

A Special Meeting of the Village of Millerton Board of Trustees was held on Monday, April 1, 2024. The meeting was called to order at 6:00 PM with Mayor Jenn Najdek presiding. Trustee Matt Hartzog, Trustee David Sherman, Trustee Lisa Hermann, and Clerk/Treasurer Lisa Cope were present. Deputy Mayor Alicia Sartori was absent. Roll call was completed.

### Discussion of oil tank removal at Old Village Hall:

The board discussed the two proposals received for the removal of the underground oil tank at the old village hall. (1) proposal was to abandon the tank in place, the second proposal was to completely remove the tank from the ground.

A *Motion* was made by Trustee Hermann and seconded by Trustee Hartzog to approve the Tentative Budget with modifications. All four (4) present members agreed. The public hearing on the tentative budget is scheduled for Monday, April 15, 2024.
