Prior Planning Study

- 2018 Millerton Pedestrian Plan by the Dutchess County Transportation Council
- Study notes that the street is primarily used for parking, however no parking spaces are marked. Overall, it is uncomfortable and unsafe to walk along or across
- Study recommends a walkable redesign of Century Boulevard including:
 - Pavement Striping
 - Marked parking spaces
 - Crosswalks at both ends and midblock
 - Sidewalks on both sides
 - Street trees and pedestrian-scale lights



Future vision plan (above) and rendering (below) of Century Boulevard included in the 2018 Millerton Pedestrian Plan









- Commercial (primary uses as office or retail)

Opportunities and Constraints - Utilities

- Existing overhead wires and utility poles currently exist along Century Boulevard
- Proposed sewer line offers opportunity for Century Boulevard improvements during install
- Improvements over water main may be limited due to potential need for access in future
- Opportunities for green infrastructure to capture stormwater runoff and treat to reduce amount of untreated stormwater enter drainage system




Preliminary Proposed Sewer Connection





Opportunities and Constraints - Topography


- 2' Interval Contours Shown
- Currently water collects on Century Boulevard
- Overall drainage tracks to the southeast corner
- Steep slopes adjacent to Century Boulevard reduce amount of space that can be used for pedestrians or green infrastructure
- Opportunity to work with existing topography to identify best locations for green infrastructure





Opportunities and Constraints – Property and Parcel Lines


- Geometry of property lines along south side of Century Boulevard vary, resulting in varying widths of Century Boulevard. Varying widths will impact amount of parking and width of pedestrian facilities
- Wider sections of Century Boulevard provide opportunities for green infrastructure locations or pedestrian facility improvements including wider sidewalks and potential seating areas
- Approximate Dimensions Shown
- Width ranges between approximately 70' 93'















What is a Complete Street?

- Street design that features the needs for all users, including pedestrians, bicyclists, motorists, and public transit
- Design includes features such as:
 - Sidewalks
 - Paved shoulders suitable for cycling
 - Lane striping
 - Bike lanes and shared bike lanes
 - Crosswalks; raised crosswalks and ramps
 - Bulb-outs (curb extensions)
 - Traffic calming measures
- Can include vegetation to provide shade and buffer from traffic
- Can include green infrastructure to manage stormwater
- Goal is to create a cleaner, greener transportation while reducing traffic congestion and air pollution

- Hold Public Meeting #2 early March 2025
- Refine concept to preferred plan March 2025
- Develop concept level opinion of probable Construction Cost & Present plan and costs to Village Board – April 2025
- Seek grant funds to design and construction – June 2025
