A Workshop Meeting of the Village of Millerton Board of Trustees was held Tuesday, September 9, 2025. The meeting was called to order at 6:00 PM with Mayor Jenn Najdek presiding. Deputy Mayor Matt Hartzog, Trustee David Sherman, Trustee Matt Soleau, Trustee Katie Cariello, and Clerk/Treasurer Lisa Cope were present. Roll call was completed.

Minutes

A **Motion** was made by Deputy Mayor Hartzog and seconded by Trustee Sherman to approve the minutes from 8/26/2025. All five (5) present members agreed.

Vouchers

A **Motion** was made by Deputy Mayor Hartzog and seconded by Trustee Soleau to approve voucher number 2022489-2022506 in the amount of General \$8,209.38, DPW Fire Expense \$11,150.37, Water \$7,152.06 for a total of \$26,511.81. All five (5) present members agreed.

Resolution 2025-42 Adopting a Pro Housing Pledge

A **Motion** was made by Trustee Cariello and seconded by Deputy Mayor Hartzog to adopt the Pro-Housing Communities Pledge. All five (5) present members agreed.

Public Hearing – Renewing Altice Franchise Agreement

A **Motion** was made by Trustee Soleau and seconded by Trustee Sherman to open the Public Hearing at 6:05 PM to discuss renewing the Altice Franchise Agreement. All five (5) present members agreed.

Roger Connor from Altice spoke on the renewal.

A **Motion** was made by Trustee Soleau and seconded by Deputy Mayor Hartzog to close the Public Hearing for the Altice Franchise renewal agreement at 6:28 PM. All five (5) present members agreed.

Erin Moore of Tighe and Bond to give update on Wastewater system

Erin Moore provided a wastewater project update. The update included a map of the service area, project costs, previous and next steps in the project. Construction is expected to be complete in Spring 2028.

Mayor

A **Motion** was made by Deputy Mayor Hartzog and seconded by Trustee Sherman to sign the renewal contract for the Intermunicipal Agreement with Rhinebeck and Millbrook. All five (5) present members agreed.

The 175th Committee will be at Veterans Park promoting the 175th anniversary week. There will also be a meeting on September 30th at the North East-Millerton Library Annex to provide updates to the public of what has been planned in anticipation of the celebratory week.

A **Motion** was made by Trustee Sherman and seconded by Deputy Mayor Hartzog to file an extension for the 2024 CDBG grant for Veteran's Park. . All five (5) present members agreed.
